11 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
12 *Maryland,* That Section(s) of the Anne Arundel County Code (2005, as amended) read as

19 **6-1-211. Overtime pay.**

21 **(a) Eligibility.**

23 (3) [From the first full pay period beginning on or after July 1, 2015 until the last
24 full pay period ending on or before June 30, 2016, an] AN employee in the classification

1 of Police Communications Operator IV may be paid overtime compensation in
2 accordance with Office of Personnel policies and procedures.

4 SECTION 2. *And be it further enacted*, That the provisions of this Ordinance shall
5 apply the first full pay period beginning on or after July 1, 2016.

7 SECTION 3. *And be it further enacted*, That this Ordinance shall take effect 45 days
8 from the date it becomes law.


