## A BILL ENTITLED

1	AN ORDINANCE concerning: Conveyance of Surplus Property - Conservation Property
2	Herald Harbor
3	
4	FOR the purpose of approving the terms and conditions under which the County may convey
5	the County's property, consisting of 192 lots in Herald Harbor, to the Crownsville
6	Conservancy, Inc.
7	
8	WHEREAS, the County owns a parcels of land comprised of 192 lots in Herald
9	Harbor and more particularly described in Exhibit A attached hereto and made a part
10	hereof (hereinafter referred to as the "Property"); and
11	
12	WHEREAS, the County Council in Resolution No. 20-07 approved a determination
13	by the County Executive that the Property be declared surplus; and

15	WHEREAS, Crownsville Conservancy, Inc. ("Grantee") has requested that the
16	County convey the Property to it, for the sum of \$ 1.00 on the conditions set forth
17	herein and for the purpose of preserving and protecting steep slopes and sensitive
18	areas from development; and

20	WHEREAS, the County Executive has determined that the Property is not needed for
21	public use and that a disposition of the Property as proposed would be in the best
22	interests of the County; and
23	WITEDEAG
24	WHEREAS, pursuant to § 8-3-204(g) of the Anne Arundel County Code, the County
2.5	may make a private disposition of property no longer needed for public use, if the

terms and conditions of such private disposition are first approved by ordinance of the 1 County Council; and 2 3 WHEREAS, the County Council, by this ordinance, authorizes the sale of the 4 Property in accordance with the terms and conditions as set forth herein; now 5 therefore, 6 7 SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, 8 That a private disposition of the Property described in Exhibit A to Grantee is hereby 9 approved upon the following terms and conditions: 10 11 1. the sale price shall be \$ 1.00; 12 13 2. the Grantee shall be the Crownsville Conservancy, Inc.; 14 15 3. the conveyance shall be in the form of a deed without warranties; 16 17 4. the deed shall impose conservation covenants on the Property and the possibility 18 of reverter; 19 20 5. all expenses associated with the sale and conveyance of the Property shall be borne 21 by the Grantee; and 22 23 6. the sale shall be in accordance with any other reasonable conditions determined by 24 the County Executive to be necessary for the protection of the County's interest. 25 26 SECTION 2. PARCEL 1: Lots 15 through 20, Block 18, Section A, as shown on the plat entitled "Herald Harbor on the Severn, Amended Map, Section A", recorded among the plat records of Anne Arundel County, Maryland in plat book 4, folio 15, and having Tax Account Number 2-413-00153138, and being located on Elm Trail.

PARCEL 2: Lots 23 and 24, Block 18, Section A, as shown on the plat entitled "Herald Harbor on the Severn, Amended Map, Section A", recorded among the plat records of Anne Arundel County, Maryland in plat book 4, folio 15, and having Tax Account Number 2-413-90004643, and being located on Elm Trail.

PARCELS 16 AND 17 BEING a part of the property described in a deed dated August 11, 1982, from Donald P. Carter, Controller of Anne Arundel County, Maryland to the Anne Arundel County, Maryland, and recorded among the Land Records of Anne Arundel County in Liber 3512, Folio 43.

PARCEL 21: Lots 13 and 14, Block 147, Section F, as shown on the plat entitled "Herald Harbor on the Severn, Amended Map, Section F", recorded among the plat records of Anne Arundel County, Maryland in plat book 4, folio 6, and having Tax Account Number 2-413-9004-6062, and being located on Redbud Trail.

PARCEL 22: Lots 1 through 29, Block 164, Section F, as shown on the plat entitled "Herald Harbor on the Severn, Amended Map, Section F", recorded among the plat records of Anne Arundel County, Maryland in plat book 4, folio 6, and having Tax Account Number 2-413-9004-6063, and being located on Serpentine Trail.

PARCEL 23: Lots 1 through 15, Block 165, Section F, as shown on the plat entitled "Herald Harbor on the Severn, Amended Map, Section F", recorded among the plat records of Anne Arundel County, Maryland in plat book 4, folio 6, and having Tax Account Number 2-413-9004-6064, and being located on Serpentine Trail.

PARCEL 24: Lot 1, Block 77, Section D, as shown on the plat entitled "Herald Harbor on the Severn, Amended Map, Section D", recorded among the plat records of Anne Arundel County, Maryland in plat book 4, folio 7, and having Tax Account Number 2-413-9004-6056, and being located on Herald Harbor Road.

PARCELS 18 THROUGH 24 BEING a part of the same property described in a deed dated August 8, 1985, from Walter N. Chitwood, Controller of Anne Arundel County, Maryland to Anne Arundel County, Maryland, and recorded among the Land Records of Anne Arundel County in Liber 3931, Folio 180.

PARCEL 25: Lots 61, 62, 67, 68, 71, 72, and 73, Block 68, Section C, as shown on the plat entitled "Herald Harbor on the

Severn, Amended Map, Section C", recorded among the plat records of Anne Arundel County, Maryland in plat book 4, folio 17, and having Tax Account Number 2-413-90008765, and being located on Moul Road.

BEING a part of the same property described in a deed dated March 9, 1977, from Donald P. Carter, Controller of Anne Arundel County, Maryland to Anne Arundel County, Maryland, and recorded among the Land Records of Anne Arundel County in Liber 2940, Folio 403.

PARCEL 26: Lots 34, 37, 42, and 43, Block 75 Section E, as shown on the plat entitled "Herald Harbor on the Severn, Amended Map, Section E", recorded among the plat records of Anne Arundel County, Maryland in plat book 4, folio 14, and having Tax Account Number 2-413-0015-3118, and being located on Sweet Gum Trail.

BEING a part of the same property described in a deed dated February 20, 1952, from Joseph H. Griscom, Sr., Treasurer of Anne Arundel County, Maryland to Anne Arundel County, Maryland, and recorded among the Land Records of Anne Arundel County in Liber 667, Folio 437.

PARCEL 27: Lots 82 and 83, Block 75A, Section E, as shown on the plat entitled "Herald Harbor on the Severn, Amended Map, Section E", recorded among the plat records of Anne Arundel County, Maryland in plat book 4, folio 14, and having Tax Account Number 2-413-0015-4056, and being located on Serpentine Trail.
