A BILL ENTITLED

1 AN ORDINANCE concerning: Public Works – Cape St. Claire Block AZ Water Petition
2 – Capital Facility Connection Charge
3

4 FOR the purpose of establishing that the properties that will be served by the Cape St.
5 Claire Block AZ Water Project No. W804900 shall pay capital facility connection
6 charges in the amount that was in effect on July 1, 2011 if certain conditions are met.

8 WHEREAS, the Cape St. Claire Block AZ Water Project No. W804900 is a
9 petition project under Article 13, Title 5, Subtitle 3 of the Anne Arundel County
10 Code (2005, as amended); and

12 WHEREAS, at the time that a majority of the property owners to be served by the
13 Cape St. Claire Block AZ Water Project No. W804900 voted for the project to
14 proceed to final design, the capital facility connection charge was \$5,500.00, and
15 since that time the capital facility connection charge has increased each fiscal year
16 by the amount provided for in § 13-5-813(d) of the County Code; and

18 WHEREAS, the Director of Public Works has requested that the County Council
19 approve application of the capital facility connection charge of \$5,500.00 that was
20 in effect on July 1, 2011, for the properties that will be served by the Cape St.
21 Claire Block AZ Water Project No. W804900, if certain conditions are met; now,


24 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
25 *Maryland,* That the capital facility connection charge for each property to be served by
26 the Cape St. Claire Block AZ Water Project No. W804900 is hereby approved by the
27 County Council in the amount of \$5,500.00 for each affected property only if the

1 property owner applies for a connection permit within six months of written notice from
2 the Department of Public Works that the Project has been released for service.

4 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days
5 from the date it becomes law.




