4 5 6	WHEREAS, Section 610(a) of the Charter of Anne Arundel County, Maryland, provides that there is a Spending Affordability Committee that is appointed by the County Executive and confirmed by resolution of the County Council; and
7	County Executive and commined by resolution of the County Council; and
8	WHEREAS, Section 610(c) of the Charter provides that the Spending
9	Affordability Committee shall consist of one resident from each councilmanic
10	district who is knowledgeable in the field of economics, finance, fiscal planning,
11 12	or a related field; and
13	WHEREAS, Section 610(d) of the Charter provides that each member of the
14	Spending Affordability Committee shall be appointed for a term of four years not
15	to exceed two successive terms; and

17	WHEREAS, the member from District 7, whose term would have expired June
18	30, 2018, has resigned; and

20	WHEREAS, the County Executive, subject to confirmation by the County
21	Council, has appointed David G. James, a resident of District 7, to serve on the
22 23	Spending Affordability Committee for a portion of the remainder of a term
23 24	through December 31, 2017; and
25	WHEREAS, the County Council, after public hearing, finds that David G. James
26	meets the eligibility requirements under Section 610 of the Charter to serve on the
27	Spending Affordability Committee; now, therefore, be it
