5	WHEREAS, the Transportation Article, § 2-103(i), of the State Code provides that
6	the State Secretary of Transportation may apply for and receive from the federal
7	government grants-in-aid or gifts for any transportation related purpose, and may
8	make grants-in-aid to any governmental transportation agency, including any county
9	or municipal agency; and
10	WHEREAS, the Transportation Article, § 7-204(e), of the State Code provides that
11	the Maryland Transit Administration may apply for and receive grants and gifts from
12 13	the federal government and may enter into agreements for them; and
14	the rederal government and may enter into agreements for them, and
15	WHEREAS, the Maryland Transit Administration is the designated recipient in
16	Maryland for grants under the Federal Transit Act; and

18	WHEREAS, the County will be an applicant for a grant/financial assistance from the
19	Maryland Transit Administration under provisions of the Federal Transit Act; and

21	WHEREAS, the County acknowledges that the United States Department of
22	Transportation requires, in accordance with the provisions of Title VI of the Civil
23	Rights Act of 1964, that in connection with the filing of an application for assistance
24	under the Federal Transit Act, the applicant give an assurance that it will comply with
25	Title VI of the Civil Rights Act of 1964 and the United States Department of
26	Transportation requirements thereunder; and

28	WHEREAS, the County acknowledges that the agreement between the County and
29	the Maryland Transit Administration for a grant/financial assistance will impose
30	certain obligations upon the County, including the contribution of the local share of
31	the project costs; and
32	WHEREAS, the County states that it is the goal of the County that minority business
33	enterprise be encouraged to the fullest extent possible in connection with
34	cherprise be encouraged to the runest extent possible in connection with

grant/financial assistance projects, and that definite procedures shall be established

and administered to ensure that minority business shall have the maximum opportunity to participate in construction contracts, supplies, equipment contracts or consultant and other services in connection with grant/financial assistance projects; and
