1 RESOLUTION authorizing the filing of an application with the Maryland Transit
2 Administration of the Maryland Department of Transportation for a grant and other funds
3 under the Federal Transit Act
4

5 WHEREAS, the Transportation Article, § 2-103(i), of the State Code provides that
6 the State Secretary of Transportation may apply for and receive from the federal
7 government grants-in-aid or gifts for any transportation related purpose, and may
8 make grants-in-aid to any governmental transportation agency, including any county
9 or municipal agency; and
10

11 WHEREAS, the Transportation Article, § 7-204(e), of the State Code provides that
12 the Maryland Transit Administration may apply for and receive grants and gifts from
13 the federal government and may enter into agreements for them; and
14

15 WHEREAS, the Maryland Transit Administration is the designated recipient in
16 Maryland for grants under the Federal Transit Act; and
17

18 WHEREAS, the County will be an applicant for a grant/financial assistance from the
19 Maryland Transit Administration under provisions of the Federal Transit Act; and

21 WHEREAS, the County acknowledges that the United States Department of
22 Transportation requires, in accordance with the provisions of Title VI of the Civil
23 Rights Act of 1964, that in connection with the filing of an application for assistance
24 under the Federal Transit Act, the applicant give an assurance that it will comply with
25 Title VI of the Civil Rights Act of 1964 and the United States Department of
26 Transportation requirements thereunder; and

28 WHEREAS, the County acknowledges that the agreement between the County and
29 the Maryland Transit Administration for a grant/financial assistance will impose
30 certain obligations upon the County, including the contribution of the local share of
31 the project costs; and

33 WHEREAS, the County states that it is the goal of the County that minority business
34 enterprise be encouraged to the fullest extent possible in connection with
35 grant/financial assistance projects, and that definite procedures shall be established

1 and administered to ensure that minority business shall have the maximum
2 opportunity to participate in construction contracts, supplies, equipment contracts or
3 consultant and other services in connection with grant/financial assistance projects;

6 WHEREAS, Section 306 of the Anne Arundel County Charter provides that the
7 County Council shall have the power to accept gifts and grants; now, therefore, be it



9 *Resolved by the County Council of Anne Arundel County, Maryland,* That the filing of an
10 application by the County to the Maryland Transit Administration for a grant and other funds
11 under the Federal Transit Act subject to the conditions set forth in this Resolution is hereby
12 endorsed; and be it further

14 *Resolved,* That a copy of this Resolution be sent to County Executive Steven R. Schuh
15 for endorsement indicating his approval of this Resolution; and be it further

17 *Resolved,* That copies of this Resolution be sent to the Maryland Transit Administration
18 of the Maryland Department of Transportation.
