A BILL ENTITLED

1 AN ORDINANCE concerning: Public Works – Watershed Protection and Restoration
2 Program – Fiscal Year 2014 Appeals
3

4 FOR the purpose of extending the appeal deadline and providing for the waiver of
5 interest and penalties for stormwater remediation fees imposed in Fiscal Year 2014;
6 providing for the retroactive application of this Ordinance; and generally relating to
7 appeals of a stormwater remediation fee in Fiscal Year 2014.

9 WHEREAS, in accordance with §§ 13-7-101, et. seq., of the Anne Arundel
10 County Code (2005, as amended), the County adopted the Watershed Protection
11 and Restoration Program and imposed a stormwater remediation fee on the use of
12 real property improved with impervious surface beginning in Fiscal Year 2014;
13 and

15 WHEREAS, in accordance with § 13-7-104 (b), a property owner could appeal a
16 stormwater remediation fee imposed during Fiscal Year 2014 on or before August
17 15, 2013; and

19 WHEREAS, this being the first year that the stormwater remediation fee was
20 imposed, property owners filed appeals of a stormwater remediation fee beyond
21 the August 15, 2013 deadline; and


23 WHEREAS, if the County were to consider appeals of a stormwater remediation
24 fee imposed during Fiscal Year 2014 beyond the August 15, 2013 deadline, the
25 stormwater remediation fee could be corrected or revised, where appropriate,
26 during the first year of the fee being imposed; now, therefore,

1 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
2 *Maryland,* That, notwithstanding any other provision of law, the appeal of a stormwater
3 remediation fee imposed in Fiscal Year 2014 shall be submitted on or before June 30,
4 2014, and any interest or penalties imposed against an unpaid stormwater remediation fee
5 imposed in Fiscal Year 2014 shall be waived if an appeal is filed on or before June 30,
6 2014.

8 SECTION 2. *And be it further enacted,* That this Ordinance shall be construed to
9 apply retroactively to July 1, 2013.

10
11 SECTION 3. *And be it further enacted,* That this Ordinance shall take effect 45 days
12 from the date it becomes law.




