4 FOR the purpose of amending the provisions for the annual revenue expenditure
5 recommendations of the Video Lottery Facility Local Development Council;
6 requiring the review by the Video Lottery Facility Local Development Council of
7 ordinances appropriating video lottery facility local impact grant funds; and generally

1 Article 3 of this Code [for expenditure of revenue paid into the Video Lottery Facility
2 Local Impact Grant Special Revenue Fund in the annual budget for the succeeding fiscal
3 year shall be submitted to the Budget Officer, with a copy to the County Council, no later
4 than January 15th of each year] SHALL PROVIDE ANNUAL RECOMMENDATIONS TO THE
5 COUNTY EXECUTIVE FOR THE EXPENDITURE OF VIDEO LOTTERY FACILITY LOCAL
6 IMPACT GRANT FUNDS. IN ADDITION, THE VIDEO LOTTERY FACILITY LOCAL
7 DEVELOPMENT COUNCIL SHALL REVIEW ANY ORDINANCE FOR THE APPROPRIATION OF
8 FUNDS FROM THE VIDEO LOTTERY FACILITY LOCAL IMPACT SPECIAL REVENUE FUND
9 AND, ON OR BEFORE THE THIRTIETH DAY AFTER RECEIPT OF THE PROPOSED ORDINANCE,
10 REPORT ITS FINDINGS AND RECOMMENDATIONS TO THE COUNTY EXECUTIVE AND
11 COUNTY COUNCIL. THE COUNTY COUNCIL MAY NOT VOTE ON ANY ORDINANCE OR
12 RESOLUTION THAT IS SUBJECT TO THIS PARAGRAPH SUBSECTION UNTIL IT HAS EITHER
13 RECEIVED THE COUNCIL'S REPORT OR THE TIME PERIOD FOR SUBMISSION OF THE
14 REPORT HAS EXPIRED.

16 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days
17 from the date it becomes law.




