A BILL ENTITLED

1 AN ORDINANCE concerning: Watershed Protection and Restoration Program –
2 Stormwater Remediation Fee

4 FOR the purpose of providing for a certain reduction of the stormwater remediation fee;
5 and generally related to the Watershed Protection and Restoration Program.

7 BY repealing and reenacting with amendments: § 13-7-103(b)
8 Anne Arundel County Code (2005, as amended)

10 BY repealing: § 13-7-103(o) (as amended by Bill No. 2-15)
11 Anne Arundel County Code (2005, as amended)

13 BY renumbering: § 13-7-103(p) to be 13-7-103(o) (as amended by Bill No. 2-15)
14 Anne Arundel County Code (2005, as amended)

16 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
17 *Maryland,* That § 13-7-103(o) of the Anne Arundel County Code (2005, as amended)
18 (and as amended by Bill No. 2-15) is hereby repealed.

20 SECTION 2. *And be it further enacted,* That § 13-7-103(p) of the Anne Arundel
21 County Code (2005, as amended) (and as amended by Bill No. 2-15) is hereby
22 renumbered to be §13-7-103(o).

8 **13-7-103. Stormwater remediation fee.**

10 (b) **Base rate.** The base rate of the stormwater remediation fee for one equivalent
11 residential unit shall be [\$85 per year;]:

12 (1) \$85 PER YEAR FOR FISCAL YEAR 2016;

13
14 (2) \$76 PER YEAR FOR FISCAL YEAR 2017;

15
16 (3) \$67 PER YEAR FOR FISCAL YEAR 2018; AND

17
18 (4) \$58 PER YEAR FOR FISCAL YEAR 2019 AND EACH FISCAL YEAR THEREAFTER.

21 SECTION 4. *And be it further enacted*, That this Ordinance shall take effect 45 days
22 from the date it becomes law.
