4	FOR the purpose of approving a lease between 1907 Lincoln, L.L.C. and the County for a
5	building and surrounding grounds located at 122 North Langley Road, Glen Burnie,
6	Maryland, known as the Anne Arundel County Behavioral Health Building.

8	WHEREAS, 1907 Lincoln, L.L.C. (the "Landlord") previously leased the
9	building and surrounding grounds located at 122 North Langley Road, Glen
10	Burnie, Maryland to the County, used as the Anne Arundel County Behavioral
1	Health Building, for a term of 10 years, which expired on June 30, 2016; and

13	WHEREAS, the County and the Landlord entered into a new agreement of lease,
14	dated September 7, 2016, (the "Lease") for a term of 10 years, whereby the
15	County's rent was reduced from \$20.71 per square foot to \$15.68 per square foot
6	and will increase by 2% for each year of the Lease; and

18	WHEREAS, pursuant to Section 715(c) of the Anne Arundel County Charter, the
9	County may enter into a contract of lease "providing for the payment of funds at a
20	time beyond the fiscal year in which the contracts are made, if the nature of the
21 .	transactions reasonably requires the making of the contracts" so long as the
22	contract or lease is approved by ordinance; and

24	WHEREAS, in approving the Lease Agreement, the County Council is affirming
25	its obligation to appropriate funds for the financial obligations under the Lease
26	Agreement in future fiscal years; now therefore,

SECTION 1. Be it enacted by the County Council of Anne Arundel County, 1 Maryland, That it hereby approves the Lease Agreement dated September 7, 2016 2 between 1907 Lincoln, L.L.C. and Anne Arundel County, Maryland, incorporated herein 3 by reference as if fully set forth, and that copies shall be permanently kept on file in the 4 Office of the Administrative Officer to the County Council and in the Office of Real Estate. 6
