A BILL ENTITLED

AN ORDINANCE concerning: Tax Levies - Two Rivers Special Taxing District 1 2 FOR the purpose of levying and imposing the tax rates for the Two Rivers Special 3 Taxing District required by the County Budget for Fiscal Year 2014. 4 5 WHEREAS, by Bill No. 85-10, the County Council established the Two Rivers 6 Special Taxing District and authorized the issuance and sale of certain special 7 obligation bonds to fund certain infrastructure improvements relating to the 8 development and utilization of the land within the Two Rivers Special Taxing 9 District, all pursuant to Article 24, § 9-1301 of the Annotated Code of Maryland 10 and §§ 4-8-101, et seq., of the Anne Arundel County Code (2005, as amended) 11 (together, the "Act"); and 12 13 WHEREAS, by Bill No. 85-10, the County is required to determine the special 14 tax requirement applicable to such district and to levy the special tax for the Fiscal 15 Year 2014; and 16 17 WHEREAS, for Fiscal Year 2014, it has been determined that the debt service on 18 special obligation bonds and other costs related to issuance of bonds or to the 19 administration of the district will not be payable or will be paid from sources

SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That a special tax for the taxable year beginning July 1, 2013, and ending on June 30, 2014, is hereby levied and imposed pursuant to the Act and other applicable authority in the Two Rivers Special Taxing District for all taxable parcels of whatever classification at the rate of \$0.00.

SECTION 2. And be it further enacted, That this Ordinance shall take effect on July 1, 2013.
