TITLE 5. COMMERCIAL DISTRICTS

18-5-102. Permitted, conditional, special exception, and business complex auxiliary uses.

The permitted, conditional, and special exception uses allowed in each of the commercial districts, and uses auxiliary to a business complex, are listed in the chart in this section using the following key: P=permitted use; C = conditional use; SE = special exception use; and A = auxiliary to a business complex use. A blank means that the use is not allowed in the district. Except as provided otherwise in this article, uses and structures customarily accessory to permitted, conditional, and special exception uses also are allowed.

TITLE 10. CONDITIONAL USES

18-10-122. Grocery stores.

A GROCERY STORE SHALL COMPLY WITH ALL THE FOLLOWING REQUIREMENTS.

- (1) THE STRUCTURE SHALL BE LOCATED ON A LOT OF AT LEAST FIVE ACRES.
- (2) VEHICULAR ACCESS TO THE STRUCTURE SHALL BE FROM A PRINCIPAL ARTERIAL ROAD OR ROAD OF HIGHER CLASSIFICATION.
- (3) THE STRUCTURE SHALL BE LOCATED AT LEAST 250 FEET FROM A DWELLING ON AN ABUTTING LOT, UNLESS THE LOT CONTAINING THE DWELLING IS UNDER THE SAME OWNERSHIP AS THE GROCERY STORE LOT.
 - (4) THE STRUCTURE MAY NOT BE A PRINCIPAL USE IN A BUSINESS COMPLEX.

(5) SUFFICIENT BUFFERS SHALL BE INCLUDED TO SHIELD ABUTTING PROPERTIES FROM NUISANCES, INCLUDING NOISE, LIGHT AND NOXIOUS ODORS.

SECTION 3. 2. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law.
