Be it enacted by the County Council of Anne Arundel County, Maryland, 7 that the Capital Budget for the fiscal year ending June 30, 2022, is hereby amended by 8 transferring appropriations in the total amount \$97,000 from the following capital project: 9 10 Franklin Manor Dredging, Project No. Q579200 11 (General County Bonds) 97,000 12 13 to the following capital project: 14 15 Cox Creek Dredging 2, Project No. Q577300 16 17 (General County Bonds) 97,000 18 SECTION 2. And be it further enacted, That the Capital Program and Capital Projects 19 Bond Ordinance for the fiscal year ending June 30, 2022, are hereby amended in 20 accordance with the provisions of this Ordinance. 21 22 SECTION 3. And be it further enacted, That this Ordinance shall take effect from the 23 24 date it becomes law.
