1 AN ORDINANCE concerning: Finance, Taxation, and Budget – Arts Council of Anne
2 Arundel County Special Revenue Fund – Annapolis and Anne Arundel County
3 Conference and Visitors Bureau Special Revenue Fund

5 FOR the purpose of establishing an Arts Council of Anne Arundel County Special Revenue
6 Fund; establishing an Annapolis and Anne Arundel County Conference and Visitors
7 Bureau Special Revenue Fund; providing for payment of revenues restricted in use by
8 State law into the Funds; providing that the Funds shall be special, non-lapsing funds;
9 specifying the purposes for which transfers may be made from the Funds; and generally
10 relating to finance, taxation, and budget.

4 (C) **Purposes.** THE REVENUES PAID INTO THE FUND SHALL REPRESENT THE SHARE OF
5 HOTEL TAX REVENUE REQUIRED TO BE PAID BY THE COUNTY TO THE ARTS COUNCIL OF
6 ANNE ARUNDEL COUNTY, INC. UNDER § 20-603(C) OF THE LOCAL GOVERNMENT ARTICLE
7 OF THE STATE CODE.

12 (A) **Fund established.** THERE IS AN ANNAPOLIS AND ANNE ARUNDEL COUNTY
13 CONFERENCE AND VISITORS BUREAU SPECIAL REVENUE FUND.

15 (B) **Special Fund.** THE ANNAPOLIS AND ANNE ARUNDEL COUNTY CONFERENCE AND
16 VISITORS BUREAU SPECIAL REVENUE FUND IS A SPECIAL, NONLAPSING FUND.

18 (C) **Purposes.** THE REVENUES PAID INTO THE FUND SHALL REPRESENT THE SHARE OF
19 HOTEL TAX REVENUE REQUIRED TO BE PAID BY THE COUNTY TO THE ANNAPOLIS AND
20 ANNE ARUNDEL COUNTY CONFERENCE AND VISITORS BUREAU UNDER § 20-603(C) OF THE
21 LOCAL GOVERNMENT ARTICLE OF THE STATE CODE.

23 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect on July 1,
