A BILL ENTITLED

1 AN ORDINANCE concerning: Public Works – Solid Waste Collection – Solid Waste
2 Service Charge – Solid Waste Landfill and Facility Delivery Fees
3

4 FOR the purpose of modifying the solid waste service charge; providing the method by
5 which the solid waste service charge is set; modifying certain charges for delivery of
6 solid waste to a landfill or waste disposal facility; providing for the effective date of
7 this Ordinance; and generally relating to the solid waste service charge.

9 BY repealing and reenacting, with amendments: §§ 13-4-105(a) and (b); and 13-4-107(d)
10 and (e)
11 Anne Arundel County Code (2005, as amended)

13 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
14 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

ARTICLE 13. PUBLIC WORKS

TITLE 4. SOLID WASTE COLLECTION

13-4-105. Solid waste service charge.

22 (a) **Generally.** *[[The County Council shall establish]]* THERE IS a service charge *[[to*
23 *be made to]]* FOR each *[[person whose]]* property *[[is]]* supplied with County curbside
24 collection service. The service charges in the aggregate FOR COUNTY CURBSIDE

EXPLANATION: CAPITALS indicate new matter added to existing law.

Captions and taglines in **bold** in this bill are catchwords and are not law.

1 COLLECTION SERVICE shall be sufficient to defray the cost of ~~[[all]]~~ solid waste
2 ~~[[collection]]~~ services provided by the County.

3
4 (b) **Amount.** There is a service charge in the amount of ~~[[\\$298]]~~ \$341 PER FISCAL YEAR.
5 FOR THE FISCAL YEAR BEGINNING JULY 1, 2022, AND FOR EACH FISCAL YEAR THEREAFTER,
6 THE COUNTY EXECUTIVE SHALL SET THE SERVICE CHARGE FOR COUNTY CURBSIDE
7 COLLECTION SERVICE AND MAY INCREASE THE CHARGE IN AN AMOUNT NOT TO EXCEED
8 5.00% OF THE THEN CURRENT CHARGE. ANY INCREASE GREATER THAN 5.00% SHALL BE
9 SET BY THE COUNTY COUNCIL BY ORDINANCE. The service charge shall be collected as
10 provided in § 1-8-101 of this Code.

12 **13-4-107. County owned or operated landfills and solid waste disposal facilities.**

13
14 (d) **Charges.** Each person delivering solid waste shall pay the charges set forth in the
15 chart in this subsection:
16

Solid waste delivered by a commercial business	[[\\$75]] \$85 per ton
Solid waste delivered in a dump truck, flatbed truck, stake body truck, box truck, rental truck/trailer, or double axle trailer	[[\\$75]] \$85 per ton

18 (e) **Charges based on weight.** All charges based on weight shall be computed
19 proportionally, with a 60-pound minimum. When a weighing scale is unavailable or
20 inoperative and the solid waste is delivered in an open vehicle, the Department shall
21 estimate the weight of the solid waste and the charge is ~~[[\\$75]]~~ \$85 per ton in accordance
22 with the estimate. When a weighing scale is unavailable or inoperative and the solid waste
23 is delivered in a closed vehicle, the charge is ~~[[\\$33]]~~ \$37.50 per cubic yard of rated capacity.

25 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect on July 1,
26 2021.
