2	Detention Officers' and Deputy Sheriffs' Retirement Plan – Employees' Retirement

5	FOR the purpose of modifying participants in the Detention Officers' and Deputy Sheriffs'
6	Retirement Plan eligible to participate in the deferred retirement option plan ("DROP");
7	modifying the number of certain employees who can begin to participate in the plan in
8	any month; providing that a Superintendent of Detention Facilities in the position
9	before a certain date may participate in the Detention Officers' and Deputy Sheriffs'
10	Retirement Plan; modifying the job classifications eligible to participate in the
11	Detention Officers' and Deputy Sheriffs' Retirement Plan; providing for participation
12	in the Detention Officers' and Deputy Sheriffs' Retirement Plan of employees in
13	certain classifications promoted after a certain date; and generally relating to pensions.

PENSIONS** 12 **TITLE 1. GENERAL PROVISIONS** 13 14 5-1-503. Eligibility. 15 16 17 (c) Detention Officers' and Deputy Sheriffs' Retirement Plan. A [[category I]] participant in the Detention Officers' and Deputy Sheriffs' Retirement Plan[[, a 18 Correctional Facility Administrator, an Assistant Correctional Facility Administrator, and 19 20 a Superintendent of Detention Facilities who has elected to participate in the Detention Officers' and Deputy Sheriffs' Retirement Plan]] is eligible to participate in the DROP if 21 the participant is actively employed by the County in a position covered by the Detention 22 23 Officers' and Deputy Sheriffs' Retirement Plan and has completed 20 years of actual plan 24 service. 25 5-1-505. Limitation on the number of participants. 26 27 (a) Generally. Except as provided in subsections (b), [[and]] (c), AND (D), the number 28 29 of employees who may begin participating in the DROP in a plan shall be limited to four new employees participating in each DROP plan as of the first day of any month. 30 31 32 (D) Correctional Program Specialists and Criminal Justice Program Specialists. 33 IN ADDITION TO THE EMPLOYEES DESCRIBED IN SUBSECTION (A), A COMBINED TOTAL OF 34 TWO NEW EMPLOYEES IN THE CLASSIFICATIONS OF CORRECTIONAL PROGRAM 35 SPECIALIST AND CRIMINAL JUSTICE PROGRAM SUPERVISOR MAY BEGIN PARTICIPATING 36 IN THE DROP AS OF THE FIRST DAY OF ANY MONTH. 37 [[(e)]] (F) Waiting list. Applicants on the waiting list described in subsection [[(d)]] (E) 38 have the right of "first refusal" for DROP participation in subsequent months in the order 39 40 of their seniority, provided: 41 (1) applicants who refuse participation if offered in subsequent months shall be 42 removed from the waiting list and must reapply in order to participate in the DROP; and 43 44 (2) in subsequent months, applicants not on the waiting list shall be selected ahead 45 46

of applicants on the waiting list who have less seniority.

27 28	(II) ARE IN JOB CLASSIFICATIONS IN CATEGORY II AS DESIGNATED IN THIS SECTION BEFORE THE EFFECTIVE DATE OF BILL NO. 54-20.

21	SECTION 3. And be it further enacted, That all references in this Ordinance to "the
22	effective date of Bill No. 54-20" or words to that effect, shall, upon codification, be
23	replaced with the actual date on which this Ordinance takes effect under Section 307 of the
24	County Charter as certified by the Administrative Officer to the County Council.

26	SECTION 4. And be it further enacted, That this Ordinance shall take effect 45 days
27	from the date it becomes law.
