## A BILL ENTITLED

1 AN ORDINANCE concerning: Recreation and Parks – Civil Offenses in County Parks –  
2 Enforcement

4 FOR the purpose of making violations of provisions that prohibit specific conduct in  
5 County parks a Class E civil offense; making a violation of the time limit on mooring  
6 a boat at a pier in a County park a Class E civil offense; and generally relating to  
7 recreation and parks.

9 BY repealing and reenacting, with amendments: § 14-3-101(c)  
10 Anne Arundel County Code (2005, as amended)

12 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
13 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

### ARTICLE 14. RECREATION AND PARKS

#### TITLE 3. ENFORCEMENT

##### 14-3-101. Enforcement.

21 (c) **Civil offenses.** It is a Class E civil offense to violate ~~[[§§ 14-2-115(c) through (e),~~  
22 14-2-118, and 14-2-119 of this Code]] ANY PROVISION OF THIS ARTICLE OR § 9-1-706 in a  
23 park.

25 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect 45 days  
26 from the date it becomes law.
