A BILL ENTITLED

1 AN ORDINANCE concerning: Scenic and Historic Roads – Designation of Roads –
2 Furnace Avenue and Ridge Road

3
4 FOR the purpose of amending the map entitled “Scenic and Historic Roads, 2006” to
5 include certain roads; adopting an amended map; and generally relating to scenic and
6 historic roads.

7
8 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
9 That, notwithstanding any other provision of law, the map entitled “Scenic and Historic
10 Roads, 2006”, dated March 2, 2006, as adopted by Bill No. 21-06, is amended to include:

12 (1) The section of Furnace Avenue between the Howard County line and River
13 Road in Linthicum Heights as shown in Exhibit 1 attached hereto.

15 (2) The section of Ridge Road between the intersection with Furnace Avenue and
16 295 North as shown in Exhibit 2 attached hereto.

18 SECTION 2. *And be it further enacted,* That the map entitled “Scenic and Historic
19 Roads, 2006”, dated March 2, 2006, as amended by Section 1 of this Ordinance,
20 incorporated herein by reference as if fully set forth, is adopted.

22 SECTION 3. *And be it further enacted,* That a certified copy of the official map shall
23 be kept permanently on file by the Administrative Officer to the County Council and the
24 Office of Planning and Zoning.

26 SECTION 4. *And be it further enacted,* That this Ordinance shall take effect 45 days
27 from the date it becomes law.

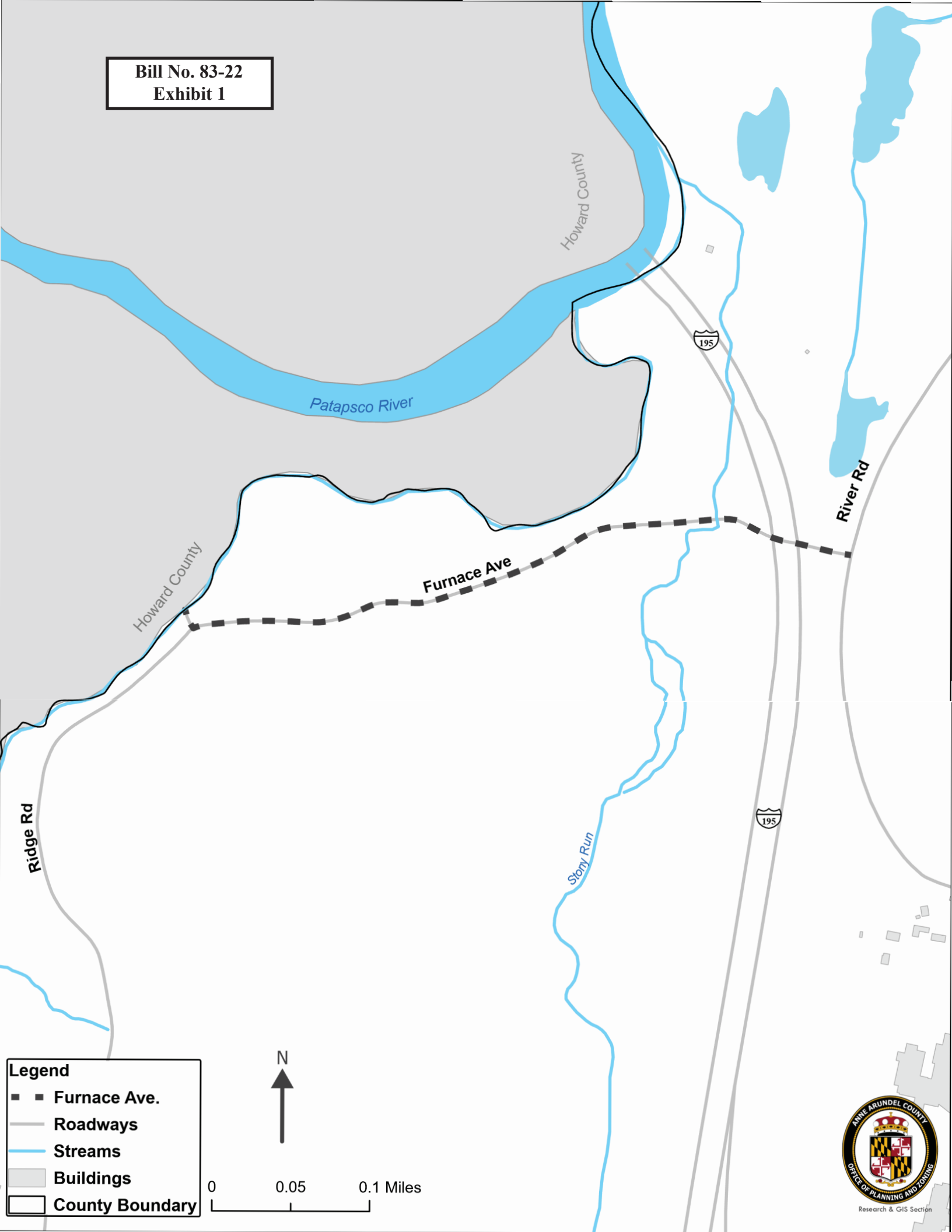

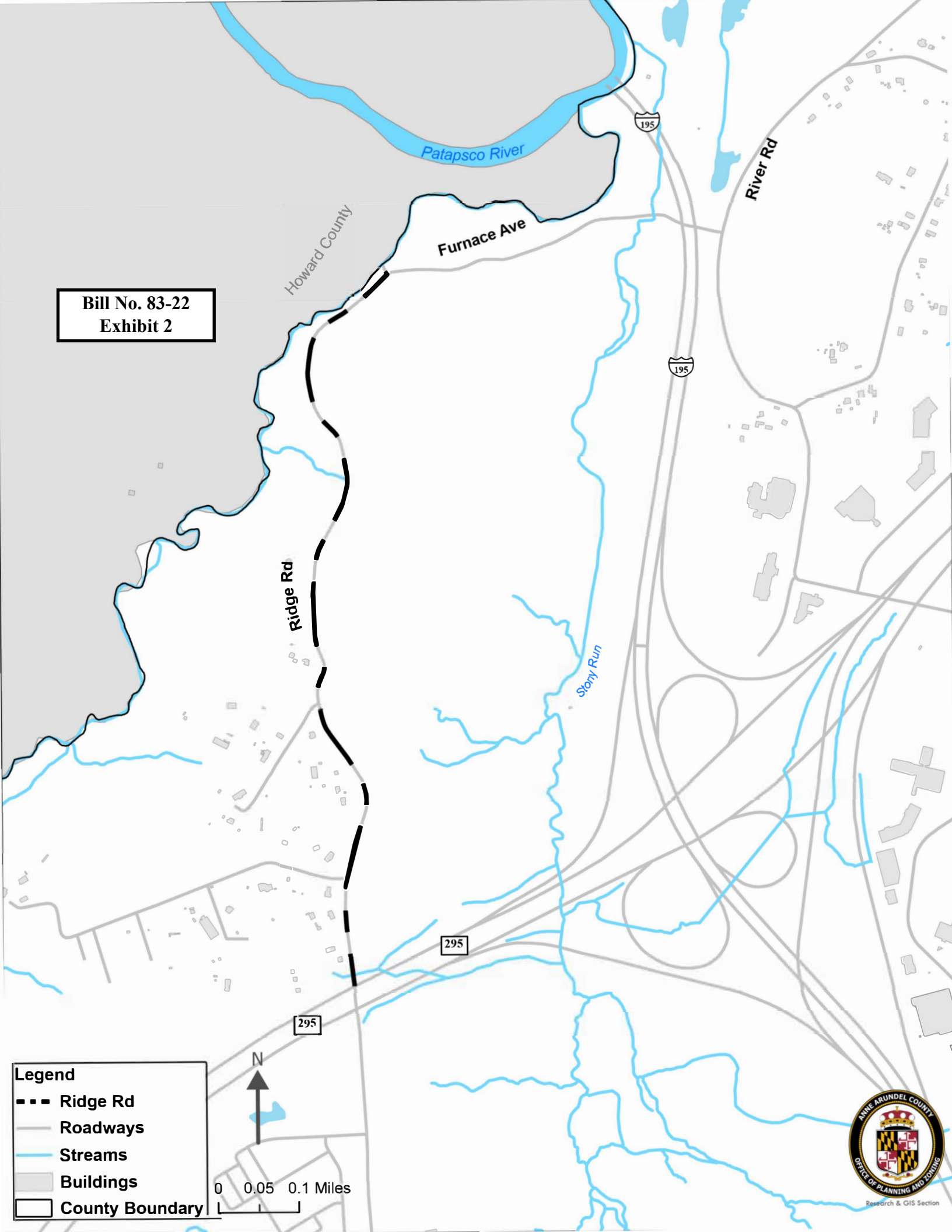
