A BILL ENTITLED

1 AN ORDINANCE concerning: Capital Budget and Program – Marley Creek Dredging –
2 Fund Transfer

4 FOR the purpose of amending the Capital Budget by transferring appropriation of funds
5 from the Church Creek Dredging, Pocahontas Creek Dredging, Duvall Creek
6 Dredging, Rockhold Crk County Dredging, and DMP Site Management capital
7 projects to the Marley Creek Dredging capital project; and amending the Capital
8 Program and Capital Projects Bond Ordinance.

10 BY amending: Capital Budget

14 WHEREAS, the Marley Creek Dredging capital project, Project No. Q567700,
15 has an existing appropriation; and
16

17 WHEREAS, Section 716 of the Charter authorizes the County Council, upon
18 request of the County Executive and by the affirmative vote of five members of
19 the County Council, to amend the capital budget; and
20

21 WHEREAS, Section 711(b) of the Charter authorizes the County Council, upon
22 request of the County Executive, to transfer appropriations between capital
23 projects in the Capital Budget; and

25 WHEREAS, the County Executive is requesting that a total of \$468,474 be
26 transferred from the Pocahontas Creek Dredging capital project, Project No.
27 D562800, the Church Creek Dredging capital project, Project No. Q567600, the

1 Duvall Creek Dredging capital project, Project No. Q548200, the Rockhold Crk
2 County Dredging capital project, Project No. D562700, and the DMP Site
3 Management capital project, Project No. Q500000, to the Marley Creek Dredging
4 capital project, Project No. Q567700; and

6 WHEREAS, the Planning Advisory Board has recommended amendments to the
7 Capital Budget in accordance with Section 716 of the Charter; and
8

9 WHEREAS, the Controller has certified in writing that such funds are available
10 for appropriation; and

12 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
13 *Maryland,* that the Capital Budget for the fiscal year ending June 30, 2017, is hereby
14 amended by transferring appropriations in the total amount \$468,474 from the following
15 capital projects:



46 date it becomes law.


