1 PROPERTY OR ANY AREA IN WHICH THE COMMUNITY HAS ANY INTEREST IN REAL 2 PROPERTY, AND COMMUNITY-WIDE PROJECTS, INCLUDING, BUT NOT LIMITED TO, [and 3 snow removal from, non-County-owned roads, streets, PATHWAYS, EASEMENTS, alleys, sidewalks, curbs, [street or road] signs, [street or road lights, bulkheads,] drainage 4 ditches, BOAT RAMPS, PIERS, GROINS, BULKHEADS, BREAKWATERS, AND LIGHTING[, and 5 6 culverts; maintenance of community areas; maintenance and improvement of real property or any interest in real property necessary to accomplish community- wide 7 projects]; community security; SHORE EROSION CONTROL; and [defraying the] ANY 8 administrative costs incidental to the foregoing purposes, including [postage, auditing, 9 10 insurance, legal costs, and THE repayment of any loan.

(3) The Shoreham Beach [Community] CITIZENS Association, Inc., a civic or community association that meets the requirements of § 4-7-101(d), shall be responsible for administering the Shoreham Beach Special Community Benefit District in furtherance of the purposes of the district.
