## A BILL ENTITLED

1	AN ORDINANCE concerning: Finance, Taxation, and Budget – Real Property Taxes –
2	Credits – Public Safety Officers Property Tax Credit
3 4	FOR the purpose of repealing a provision that allows for an administrative fee for the
4 5	administration of the public safety officer property tax credit; and generally relating to
6	finance, taxation, and budget.

8	BY repealing and reenacting, with amendments: § 4-2-313(e) (as amended by Bill No. 17-
9	20)
10	Anne Arundel County Code (2005, as amended)

12	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland,
13	That Section(s) of the Anne Arundel County Code (2005, as amended)(and as amended by
14	Bill No. 17-20) read as follows:

16	<b>ARTICLE 4. FINANCE, TAXATION, AND BUDGET</b>
17	
18	TITLE 2. REAL PROPERTY TAXES
19	
20	4-2-313. Public Safety Officers property tax credit.
21	
22	(e) <b>Duration.</b> The tax credit shall be available to a Public Safety Officer eligible under
23	subsection (c) for a period of one taxable year and may be renewed upon application of the
24	Public Safety Officer for four additional taxable years, for a maximum total of five taxable
25	years. [[An administrative fee of 1% of the total tax credit may be assessed for
26	administration of the credit for the duration of the credit.]]

SECTION 2. And be it further enacted, That this Ordinance shall take effect 45 days
from the date it becomes law.
