6 BY repealing and reenacting, with amendments: § 4-7-204(qqq)(2)
7 Anne Arundel County Code (2005, as amended)

9 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
10 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

12 **ARTICLE 4 FINANCE, TAXATION, AND BUDGET**

14 **TITLE 7. SPECIAL COMMUNITY BENEFIT DISTRICTS, SHORE EROSION**
15 **CONTROL DISTRICTS, AND WATERWAYS IMPROVEMENT DISTRICTS**

17 **4-7-204. Districts established.**

19 **(qqq) Venice Beach Special Community Benefit District.**

21 (2) The district is established for the purpose of supporting an erosion program;
22 [installing streetlights; hiring of special police officers; and maintenance of a road network]
23 CONSTRUCTION, MAINTENANCE, IMPROVEMENT OF, AND SNOW REMOVAL FROM NON-
24 COUNTY-OWNED ROADS, STREETS, BEACH, ALLEYS, SIDEWALKS, CURBS, STREET OR

EXPLANATION: CAPITALS indicate new matter added to existing law.
[Brackets] indicate matter stricken from existing law.

1 ROAD SIGNS AND LIGHTS, TRAFFIC CONTROL DEVICES, BULKHEADS, DRAINAGE DITCHES, AND
2 CULVERTS; ACQUIRING, IMPROVING, AND MAINTAINING COMMUNITY PROPERTY, BOTH REAL
3 AND PERSONAL, OR ANY INTEREST IN REAL PROPERTY NECESSARY TO ACCOMPLISH
4 COMMUNITY-WIDE PROJECTS; PROVIDING SPECIAL POLICE PROTECTION; AND THE FUNDING
5 OF ADMINISTRATIVE EXPENSES TO CARRY-OUT THESE PURPOSES, INCLUDING, BUT NOT
6 LIMITED TO, MAILING EXPENSES, SECRETARIAL COSTS, INSURANCE COSTS, FIDELITY BOND
7 COSTS, AUDIT FEES, ATTORNEY'S FEES, COURT COSTS, THE REPAYMENT OF ANY LOAN, AND
8 OTHER PAYMENT OF OTHER EXPENSES NECESSARY FOR THE ADMINISTRATION AND
9 IMPLEMENTATION OF THESE PURPOSES.

11 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days from
12 the date it becomes law.






