### **8-1-101.** Definitions.

In this article, the following words have the meanings indicated.

(6) "RELATED ENTITIES" MEANS CORPORATIONS, GENERAL PARTNERSHIPS, LIMITED PARTNERSHIPS, LIMITED LIABILITY COMPANIES, OR OTHER BUSINESS ENTITIES THAT HAVE SIMILAR PURPOSES AND HAVE:

(I) SUBSTANTIALLY SIMILAR MEMBERSHIP OR SUBSTANTIALLY THE SAME DIRECTION OR CONTROL, WHETHER DIRECT OR INDIRECT; OR

(II) COMMON OWNERSHIP, WHETHER DIRECT OR INDIRECT, OF A 50 PERCENT OR GREATER INTEREST IN THE CAPITAL OR PROFITS OF THE OTHER.

## **TITLE 2. PROCUREMENT**

#### 8-2-103. Procurement Methods

(b) **Certain multiple contracts.** Multiple contracts for the same goods or services may be awarded to responsive and responsible vendors under any procurement method established in the Purchasing Manual if it is in the County's best interests, such as when awards to two or more vendors are needed for adequate delivery, service, or availability, or for product compatibility. WHEN MULTIPLE CONTRACTS FOR THE SAME GOODS OR SERVICES ARE AWARDED TO TWO OR MORE RESPONSIVE AND RESPONSIBLE VENDORS TO ENSURE ADEQUATE DELIVERY, SERVICE, OR AVAILABILITY, THE VENDORS TO WHOM THE CONTRACTS ARE AWARDED MAY NOT BE RELATED ENTITIES.

SECTION 2. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law.
