1 RESOLUTION confirming the appointments of members to serve on the Personnel
2 Board for Anne Arundel County

4 WHEREAS, Section 520 of the Charter of Anne Arundel County, Maryland,
5 provides that there shall be a Personnel Board consisting of five qualified voters
6 appointed by the County Executive and confirmed by resolution of the County
7 Council; and

9 WHEREAS, Section 520 of the Charter provides that one member shall always be
10 a member of the classified service as defined in Section 803 of the Charter, and he
11 shall be selected from a list of three names nominated by secret ballot by the
12 members of the classified service; and

14 WHEREAS, Section 520 of the Charter provides that the terms of the members
15 are coterminous with that of the County Executive, that a member shall serve until
16 a successor is appointed and qualified, and that vacancies shall be filled for the
17 unexpired term in the manner of original appointment; and

19 WHEREAS, the term of the member of the classified service expired when the
20 newly elected County Executive qualified to serve his term on the first Monday in
21 December, 2014; and

23 WHEREAS, Michael E. Malone, a qualified voter whose term would have
24 expired on November 30, 2018, resigned as a member of the Personnel Board
25 effective March 25, 2015; and

27 WHEREAS, the County Executive, subject to confirmation by the County
28 Council, has appointed John Michael Mostakis, a qualified voter and a member of
29 the classified service, to a term that expires on November 30, 2018, and Alan R.
30 Friedman, a qualified voter, to complete the term that expires on November 30,
31 2018; and



33 WHEREAS, the County Council, after public hearing, finds that John Michael
34 Mostakis and Alan R. Friedman meet the eligibility requirements under Section
35 520 of the Charter of Anne Arundel County, Maryland, and are qualified to serve
36 on the Personnel Board; now, therefore, be it

1 *Resolved by the County Council of Anne Arundel County, Maryland,* That it hereby
2 approves the appointments to the Personnel Board of John Michael Mostakis, a qualified
3 voter and a member of the classified service, and Alan R. Friedman, a qualified voter, to
4 terms that expire on November 30, 2018; and be it further

6 *Resolved,* That a copy of this Resolution be sent to County Executive Steven R.
7 Schuh, appointees John Michael Mostakis and Alan R. Friedman, and Arlene Berlin,
8 Director of Boards and Commissions.


