Council; and

a member of the classified service as defined in Section 803 of the Charter, and he shall be selected from a list of three names nominated by secret ballot by the
members of the classified service; and

are coterminous with that of the County Executive, that a member shall serve until
a successor is appointed and qualified, and that vacancies shall be filled for the
unexpired term in the manner of original appointment; and

newly elected County Executive qualified to serve his term on the first Monday in
December, 2014; and
WHEREAS, Michael E. Malone, a qualified voter whose term would have
expired on November 30, 2018, resigned as a member of the Personnel Board
effective March 25, 2015; and
WHEREAS, the County Executive, subject to confirmation by the County
Council, has appointed John Michael Mostakis, a qualified voter and a member of
the classified service, to a term that expires on November 30, 2018, and Alan R.
Friedman, a qualified voter, to complete the term that expires on November 30,
2018; and

WHEREAS, the County Council, after public hearing, finds that John Michael
Mostakis and Alan R. Friedman meet the eligibility requirements under Section
