A BILL ENTITLED

1 AN ORDINANCE concerning: Current Expense Budget – Supplementary Appropriations –
2 Bittersweet Special Community Benefit District and Wilelinor Special Community
3 Benefit District
4

5 FOR the purpose of making supplementary appropriations from unanticipated revenues to
6 the Bittersweet Special Community Benefit District and the Wilelinor Special
7 Community Benefit District for the fiscal year ending June 30, 2016.
8

9 BY amending: Current Expense Budget
10

11 WHEREAS budget requests have been submitted on behalf of the Bittersweet
12 Special Community Benefit District and the Wilelinor Special Community Benefit
13 District to appropriate revenues that were not appropriated for the fiscal year ending
14 June 30, 2016; and
15

16 WHEREAS, these revenues were not anticipated in the Current Expense Budget; and
17

18 WHEREAS, Section 712 of the Charter authorizes the County Council, upon the
19 recommendation of the County Executive, to make supplementary appropriations
20 from revenues received from sources not anticipated in the budget or from revenues
21 received from anticipated sources but in excess of budget estimates for the current
22 fiscal year, provided that the Controller shall first certify in writing that the funds are
23 available for appropriation; and

1 WHEREAS, the County Executive has recommended supplementary appropriations,
2 and the Controller has certified in writing that such funds are available for
3 appropriation; now, therefore,


5 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
6 That the Current Expense Budget for the fiscal year ending June 30, 2016, is hereby amended
7 by making supplementary appropriations from revenues received from sources not
8 anticipated in the budget to the Bittersweet SCBD in the amount of \$15,481.
9

10 SECTION 2. *And be it further enacted,* That the Current Expense Budget for the fiscal
11 year ending June 30, 2016, is hereby amended by making supplementary appropriations from
12 revenues received from anticipated sources but in excess of budget estimates to the Wilelinor
13 SCBD in the amount of \$12,198.
14

15 SECTION 3. *And be it further enacted,* That this Ordinance shall take effect 45 days
16 from the date it becomes law.




