4	WHEREAS, Section 610(a) of the Charter of Anne Arundel County, Maryland,
5	provides that there is a Spending Affordability Committee that is appointed by the
6	County Executive and confirmed by resolution of the County Council; and

8	WHEREAS, Section 610(c) of the Charter provides that the Spending
9	Affordability Committee shall consist of one resident from each councilmanic
10	district who is knowledgeable in the field of economics, finance, fiscal planning,
11	or a related field; and

13	WHEREAS, Section 610(d) of the Charter provides that each member of the
14	Spending Affordability Committee shall be appointed for a term of four years not
15	to exceed two successive terms; and
16	
17	WHEREAS, the terms of the members from Districts 1, 5, and 6 expired
18	December 1, 2014, and the positions are vacant; and
19	
20	WHEREAS, the County Executive, subject to confirmation by the County
21	Council, has appointed Debi Sandlin, a resident of District 1, to serve on the
22	Spending Affordability Committee for the remainder of a term beginning on
23	October 1, 2015, and ending on December 1, 2018; J. Timothy Connolly, a
24	resident of District 5, to serve on the Spending Affordability Committee for the
25	remainder of a term beginning on October 1, 2015, and ending on December 1,
26	2018; and Jerry L. Pesterfield, a resident of District 6, to serve on the Spending
27	Affordability Committee for the remainder of a term beginning on October 1,
28	2015, and ending on December 1, 2018; and

30	WHEREAS, the County Council, after public hearing, finds that Debi Sandlin, J.
31	Timothy Connolly, and Jerry L. Pesterfield meet the eligibility requirements
32	under Section 610 of the Charter to serve on the Spending Affordability
33	Committee; now, therefore, be it

35	Resolved by the County Council of Anne Arundel County, Maryland, That it hereby

approves the appointments of Debi Sandlin as the District 1 member of the Spending

Affordability Committee for the remainder of a term beginning on October 1, 2015, and
