18	County Executive, the County Council may make supplementary appropriations
19	from contingent funds, provided that the Controller shall first certify in writing
20	that such funds are available for appropriation; and

WHEREAS, the Failed Sewage&Private Well Fnd capital project, Project No. 1 C501100, has an existing appropriation in the Capital Budget for the fiscal year 2 3 ending June 30, 2016, and additional funds in excess of budget estimates have 4 become available; and 5 WHEREAS, pursuant to Sections 712 and 716 of the Charter, upon 6 7 recommendation of the County Executive, the County Council may make supplementary appropriations to the Capital Budget from revenues received from 8 anticipated sources but in excess of budget estimates for the current fiscal year; 9 10 and 11 12 WHEREAS, Section 716 of the Charter authorizes the County Council, upon 13 request of the County Executive and by affirmative vote of five members of the 14 County Council, to amend the Capital Budget; and 15 WHEREAS, the County Executive has recommended a supplementary 16 appropriation to the Failed Sewage&Private Well Fnd capital project, Project No. 17 18 C501100, from the Office of Finance (Non-Departmental), Pay-as-you-Go 19 Account, revenues received from an anticipated source but in excess of budget 20 estimates for the current fiscal year; and 21 WHEREAS, in accordance with Section 716 of the Charter, the Planning 22 23 Advisory Board has recommended this amendment to the Capital Budget; and 24 25 WHEREAS, the Controller has certified in writing that the funds are available for 26 transfer; now, therefore, 27 28 SECTION 1. Be it enacted by the County Council of Anne Arundel County, 29 Maryland, That the Current Expense Budget for the fiscal year ending June 30, 2016, is 30 hereby amended by making a supplementary appropriation from contingent funds as 31 follows: 32 33 Chief Administrative Officer 34 Contingency \$ 35,000 35 Grants, Contributions & Other 36 37 and by adding such funds to the below-listed department in the amount set forth: 38 39 Office of Finance Non-Departmental 40 Pay-As-You-Go Grants, Contributions & Other \$ 35,000 41 42 SECTION 2. And be it further enacted, That the Capital Budget for the fiscal year 43 ending June 30, 2016, is hereby amended by making a supplementary appropriation in 44 the amount of \$35,000 from Office of Finance Non-Departmental, Pay-As-You-Go, 45 Grants, Contributions & Other, to the Failed Sewage&Private Well Fnd capital project, 46

1 SECTION 3. And be it further enacted, that the Capital Program and the Capital 2 Projects Bond Ordinance for the fiscal year ending June 30, 2016, are hereby amended in 3 accordance with the provisions of this Ordinance. 4 SECTION 4. And be it further enacted, That this Ordinance shall take effect 45 days 5 from the date it becomes law.
