3 FOR the purpose of modifying the purposes of the Gibson Island Special Community Benefit
4 District.

6 BY repealing and reenacting with amendments: § 4-7-204(z)
7 Anne Arundel County Code (2005, as amended)

9 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
10 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

12 **ARTICLE 4. FINANCE, TAXATION, AND BUDGET**

14 **TITLE 7. SPECIAL COMMUNITY BENEFIT DISTRICTS, SHORE EROSION**
15 **CONTROL DISTRICTS, AND WATERWAYS IMPROVEMENT DISTRICTS**

17 **4-7-204. Districts established.**

19 **(z) Gibson Island Special Community Benefit District.**

21 (1) The limits of the Gibson Island Special Community Benefit District are the
22 subdivision known as Gibson Island as shown on the plats of Gibson Island recorded among
23 the plat records of the County in Plat Book No. 4, Folio Nos. 45, 46, 47, 48, and 49; and Plat

3 (2) The district is established for the purpose of the construction, maintenance, and
4 repair of non-County-owned roads, streets, causeways, alleys, sidewalks, street or road signs,
5 street or road lights, drainage ditches, storm drains, and culverts; [and] shore erosion control,
6 prevention, protection, and repair; ACQUISITION, IMPROVEMENT, MAINTENANCE, AND
7 CONSTRUCTION OF COMMUNITY OWNED REAL AND PERSONAL PROPERTY; TRASH,
8 RECYCLING, AND YARD WASTE COLLECTION AND REMOVAL; COMMUNITY SECURITY; AND
9 THE ADMINISTRATIVE EXPENSES INCIDENTAL TO CARRYING OUT THESE PURPOSES,
10 INCLUDING REPAYMENT OF ANY LOAN, INTEREST THEREON, AND ANY NECESSARY
11 INSURANCE COSTS.

12
13 (3) The Gibson Island Corporation[,Inc.], a civic or community association that meets the
14 requirements of § 4-7-101(d), shall be responsible for the expenditure of the special
15 assessments collected from the Gibson Island Special Community Benefit District.

16
17 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days from
18 the date it becomes law.




