1 2 3	AN ORDINANCE concerning: Capital Budget and Program – Cowhide Branch Retro – Supplementary Appropriations
4 5 6 7 8	FOR the purpose of making a supplementary appropriation of funds from unanticipated revenues to the Cowhide Branch Retro capital project, Project No. Q517400; and amending the Capital Program and Capital Projects Bond Ordinance for the fiscal year ending June 30, 2017.
9 10 11 12	BY amending: Capital Budget Capital Program Capital Projects Bond Ordinance
13 14 15 16	WHEREAS, the Cowhide Branch Retro capital project, Project No. Q517400, has an existing appropriation in the Capital Budget for the fiscal year ending June 30, 2017, and additional funds in excess of budget estimates have become available; and
18 19 20 21 22 23	WHEREAS, pursuant to Sections 712 and 716 of the Charter, upon recommendation of the County Executive, the County Council may make supplementary appropriations to the Capital Budget from revenues received from anticipated sources but in excess of budget estimates for the current fiscal year; and
24 25 26 27	WHEREAS, additional funding in the amount of \$800,000 has become available for the Cowhide Branch Retro capital project from a grant under the Transportation Enhancement Program of the Maryland Department of Transportation, which is funded through the federal "Safe, Accountable, Flexible,

Efficient Transportation Equity Act: A Legacy for Users"; and 1 2 3 WHEREAS, Section 716 of the Charter authorizes the County Council, upon 4 request of the County Executive and by affirmative vote of five members of the 5 County Council, to amend the Capital Budget; and 6 7 WHEREAS, the County Executive has recommended a supplementary 8 appropriation to the Cowhide Branch Retro capital project, Project No. O517400. 9 in the amount of \$800,000, revenues received from an anticipated source but in 10 excess of budget estimates for the current fiscal year; and 11 12 WHEREAS, in accordance with Section 716 of the Charter, the Planning 13 Advisory Board has recommended this amendment to the Capital Budget; and 14 15 WHEREAS, the Controller has certified in writing that the funds are available for 16 transfer; now, therefore, 17 18 SECTION 1. Be it enacted by the County Council of Anne Arundel County, 19 Maryland, That the Current Expense Budget for the fiscal year ending June 30, 2017, is 20 hereby amended by making a supplementary appropriation in the amount of \$800,000 21 from the Transportation Enhancement Program of the Maryland Department of 22 Transportation, which are revenues received from anticipated sources but in excess of 23 budget estimates, to the Cowhide Branch Retro capital project, Project No. Q517400 24 (Other Fed Grants). 25 26 SECTION 2. And be it further enacted, that the Capital Program and the Capital 27 Projects Bond Ordinance for the fiscal year ending June 30, 2017, are hereby amended in 28 accordance with the provisions of this Ordinance. 29 30 SECTION 3.
