### TITLE 10. REQUIREMENTS FOR CONDITIONAL USES

# 18-10-119. Funeral Establishments

to permitted, conditional, and special exception uses also are allowed.

Permitted, Conditional, Special Exception, and Business

Funeral establishments on a collector or arterial road.

FUNERAL ESTABLISHMENTS ON A LOCAL ROAD

A FUNERAL ESTABLISHMENT SHALL COMPLY WITH THE FOLLOWING REQUIREMENTS:

(1) THE FACILITY SHALL BE LOCATED ON A LOT OF AT LEAST 20,000 SQUARE FEET .

(2) THE FACILITY SHALL BE LOCATED AT LEAST 25 FEET FROM THE LOT LINE OF A RESIDENTIALLY ZONED OR OCCUPIED PROPERTY

SECTION 3. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law.
