1 RESOLUTION approving the application and receipt of financing for a Community
2 Legacy Project in Brooklyn Park, Maryland, to be financed either directly by the
3 Department of Housing and Community Development of the State of Maryland (the
4 "Department") or through other departments or agencies of the State of Maryland
5

6 WHEREAS, Anne Arundel County, Maryland (the "County") recognizes that
7 there is a need for reinvestment and revitalization of certain communities in the
8 Brooklyn Park area of Anne Arundel County; and
9

10 WHEREAS, by Resolution No. 29-01, the County Council of Anne Arundel
11 County has designated neighborhoods within the Brooklyn Park area of Anne
12 Arundel County, Maryland, as a Community Legacy Area ("the Area"); and

14 WHEREAS, Arundel Community Development Services, Inc. ("ACDS")
15 proposes to continue activities in the Brooklyn Park Community Legacy Area, the
16 purpose of which will be to contribute to the reinvestment and revitalization in the
17 Area and provide affordable housing opportunities for the County's workforce
18 ("the Project"); and

20 WHEREAS, the Department, either through the Community Legacy Program or
21 through other programs of the Department, or in cooperation with other State
22 departments or agencies, may provide some or all of the financing for the Project
23 (the "Project Financing") in order to assist in making it financially feasible; and

25 WHEREAS, the Area is located within a priority funding area under the State
26 Finance and Procurement Article, § 5-7B-02, of the State Code, part of the Smart
27 Growth Act, and the Project will conform to the local zoning code; and

29 WHEREAS, the applicable law and regulations require approval of the
30 Community Legacy Area designation, the Project, and the Project Financing by
31 Anne Arundel County and, where appropriate, by the chief elected executive
32 official of the local subdivision; now, therefore, be it

34 *Resolved by the County Council of Anne Arundel County, Maryland, That the County*
35 *Council hereby endorses the designation of the Community Legacy Area and the Project*
36 *in the Area, and hereby approves the request by ACDS to the Department or other*
37 *departments or agencies of the State of Maryland for Project Financing in the*

1 approximate amount of \$500,000, in the form of a grant, loan, or other financial vehicle;
2 and be it further

4 *Resolved*, That a copy of this Resolution be sent to County Executive Steven R.
5 Schuh for endorsement indicating his approval of this Resolution; and be it further

7 *Resolved*, That copies of this Resolution be sent to the Secretary of the Department of
8 Housing and Community Development of the State of Maryland and to Arundel
9 Community Development Services, Inc.
