5 RESOLUTION proposing an amendment to the Charter of Anne Arundel County to  
6 change the title of Director of Programming to Economic Development Officer  
7

8 *Be it resolved by the County Council of Anne Arundel County, Maryland,* That the  
9 following amendment to the Anne Arundel County Charter is proposed for submission to the  
10 qualified voters of the County at the General Election in November 2016:  
11

12 **Article IV. The County Executive**  
13

14 **Sec. 405. Powers and duties of the office.**  
15

16 The County Executive shall be responsible for the proper and efficient administration of  
17 such affairs of the County as are placed in the charge or under the jurisdiction and control of  
18 the County Executive under this Charter or by law. In addition to and not by way of limitation  
19 of the County Executive's general duties of supervision and management of the executive  
20 branch of the County government, the County Executive shall have the following express  
21 responsibilities, duties and powers:  
22

23 (a) To supervise, direct and control, subject to law and the provisions of this Charter, the  
24 executive branch of the County and to appoint and remove the Chief Administrative Officer,  
25 Public Information Officer, Legislative Liaison Officer, [Director of Programming] ECONOMIC  
26 DEVELOPMENT OFFICER, the County Attorney, the Planning and Zoning Officer,  
27 Administrative Hearing Officer, Director of Public Works, Director of Inspections and  
28 Permits, Chief of Police, Fire Administrator, Director of Recreation and Parks and the  
29 Director of Aging;

31 *And be it further resolved,* That the following question is adopted for submittal to the  
32 qualified voters of the County at the General Election in November 2016 for their adoption or  
33 rejection:


1        “To amend the Anne Arundel County Charter to change the title of Director of  
2 Programming to Economic Development Officer in Section 405 of the Charter.”

3  
4        *And be it further resolved*, That this question shall be designated as Question “ \_\_\_ ” on  
5 the ballot at the General Election in November 2016.

6  
7        *And be it further resolved*, That if the majority of qualified votes cast in the election are  
8 for the Charter Amendment, this amendment shall stand adopted from and after the 30<sup>th</sup> day  
9 following the election.
