A BILL ENTITLED

1 AN ORDINANCE concerning: Snug Harbor Waterways Improvement District

3 FOR the purpose of modifying the limits of the Snug Harbor Waterways Improvement; and  
4 correcting the tax account number of a certain property within the limits of the Snug  
5 Harbor Waterways Improvement District; correcting the street addresses of certain  
6 properties within the limits of the Snug Harbor Waterways Improvement District; and  
7 generally relating to the Snug Harbor Waterways Improvement District.

9 BY repealing and reenacting, with amendments: § 4-7-406(k)(1)  
10 Anne Arundel County Code (2005, as amended)

12 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*




