1 RESOLUTION approving the declaration of certain County-owned property near the
2 intersection of Pekin Road and Edwin Raynor, in Pasadena, Maryland, as surplus property
3

4 WHEREAS, § 8-3-202 of the Anne Arundel County Code (2005, as amended)
5 authorizes the County Executive to dispose of real property owned by the County
6 when the County Executive, with the approval of the County Council, has determined
7 that the real property is surplus property; and
8

9 WHEREAS, the County Executive has determined that the property described below
10 (“the Property”) is surplus property and wishes to dispose of it in accordance with
11 Article 8, Title 3, Subtitle 2 of the County Code; and
12

13 WHEREAS, the County Council, after a public hearing on this Resolution, finds that
14 the public interest will be furthered by declaring the Property to be surplus property;
15 now, therefore, be it
16

17 *Resolved by the County Council of Anne Arundel County, Maryland,* That in accordance
18 with § 8-3-202 of the County Code, it hereby approves the County Executive’s determination
19 that the following property, located in the Third Assessment District, is surplus property:
20

21 ALL that real property described in Exhibit A and depicted on Exhibit B,
22 attached hereto and made a part hereof, specifically Parcel 191 Part Lot 5, as
23 shown on Plat 1124, Map 17, Grid 9, recorded in the Anne Arundel County
24 Land Records, Book 23 Page 37 recorded June 29, 1971, saving and
25 excepting all easement and or agreements of record.

27 BEING the above-described portion of the property conveyed from Melvin R.
28 Myers and Anna E. Myers to Anne Arundel County, Maryland by deed dated
29 August 21, 1972 and recorded among the land records in liber 2518, folio
30 345.

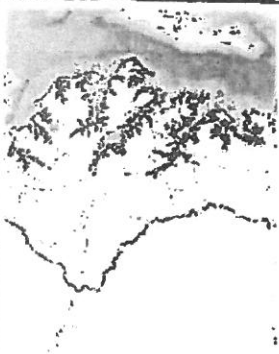
EXHIBIT A
