## A BILL ENTITLED

AN ORDINANCE concerning: Property Tax and Semiannual Payment Service Charge 1 2 3 FOR the purpose of levying and imposing a property tax for the use of Anne Arundel County for the taxable year beginning July 1, 2017, and ending June 30, 2018; fixing 4 the rate of the County property tax for the taxable year; and establishing the service 5 charge to be paid by a property owner electing to pay real property taxes and all other 6 taxes and charges billed on the real property tax bill under a semiannual payment schedule. 8 9 SECTION 1. Be it enacted by the County Council of Anne Arundel County, 10 Maryland, That a County property tax for the taxable year beginning July 1, 2017, and 11 ending June 30, 2018, is hereby levied and imposed on all assessments, persons, or 12 property subject to ordinary taxation in Anne Arundel County, and that the rate of 13 14 taxation for such taxable year is hereby fixed at: 15 16 (1) \$0.907 on each \$100 of the full assessed value of such real property, and \$2.267 on each \$100 of the full assessed value of such personal property, exclusive of 17 18 said property located within the corporate limits of the City of Annapolis and the Town of Highland Beach; 19 20 21 (2) \$0.544 on each \$100 of the full assessed value of such real property, and \$1.360 on each \$100 of the full assessed value of such personal property, located within 22 the corporate limits of the City of Annapolis; and 23 24

(3) \$0.877 on each \$100 of the full assessed value of such real property, and

\$2.192 on each \$100 of the full assessed value of such personal property, located within

the corporate limits of the Town of Highland Beach.

SECTION 2. And be it further enacted, That each property owner electing to pay real property taxes and all other taxes and charges billed on the real property tax bill under a semiannual payment schedule, for the taxable year beginning July 1, 2017, and ending June 30, 2018, shall pay a service charge of 0.22% of the amount of the tax due at the second installment.

SECTION 3. And be it further enacted, That this Ordinance shall take effect on July 1, 2017.
