1	AN ORDINANCE concerning: Current Expense Budget - Board of Education -
2	Supplementary Appropriation

4	FOR the purpose of making supplementary appropriations from unanticipated revenues to
5	the Local Education Fund for the current fiscal year; and generally relating to
6	supplementary appropriations to the current expense budget for the fiscal year ending
7	June 30, 2018.

9	BY amending: Current Expense Budget
10	
11	WHEREAS, under Section 712 of the Charter, upon the recommendation of the
12	County Executive, the County Council may make supplementary appropriations
13	from revenues received from anticipated sources but in excess of budget estimates
14	and from revenues received from sources not anticipated in the budget for the
15	current fiscal year, provided that the Controller shall first certify in writing that such
16	funds are available for appropriation; and

18	WHEREAS, § 5-105(a) of the Education Article of the Annotated Code of
19	Maryland, requires that all revenues received by the Board of Education be spent
20	in accordance with the major categories of its annual budget as provided under § 5-
21	101 of the Education Article; and

23	WHEREAS, the County Executive has recommended supplementary appropriation
24	of certain funds, and the Controller has certified in writing that such funds are
25	available for appropriation; now, therefore,
