## A BILL ENTITLED

11	WHEREAS, § 5-107(b)(1) of the Education Article of the Annotated Code of
12	Maryland requires that expenditures for school building construction be made in
13	accordance with the cost approved by the County Council for each project; and
14 15	WHEREAS, § 5-107(b)(2) of the Education Article of the Annotated Code of
16	Maryland provides that transfers between major categories or of unexpended
17	project balances are subject to the approval of the County Council; and
18	project bulances are subject to the approval of the County Council, and
19	WHEREAS, Section 711(b) of the Charter authorizes the County Council, upon
20	request of the County Executive, to transfer appropriations between capital projects
21	in the Capital Budget; and

23	WHEREAS, the County Executive is requesting that \$1,800,000 be transferred
24	from the Jessup ES Access capital project to the Jessup ES capital project; and

26	WHEREAS, the Board of Education has requested the transfer; and

SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That the Capital Budget for the fiscal year ending June 30, 2018, is hereby amended by transferring appropriations in the total amount of \$1,800,000 from the Jessup ES Access capital project, Project No. C572300 (Ed Impact Fees Dist 1), to the Jessup ES capital project, Project No. E550000 (Ed Impact Fees Dist 1).
