3	FOR the purpose of amending the compensation of members of the County Council as
4	recommended by the Salary Standard Commission; and generally relating to the
5	Legislative Branch.

7	By repealing and reenacting, with amendments: §§ 2-2-101; and 2-2-102
8	Anne Arundel County Code (2005, as amended)

10	WHEREAS, the salaries for the County Council Chair, Vice Chair and Council
11	members were last set by the County Council in 2002, and

13	WHEREAS, the Anne Arundel County Salary Standard Commission has submitted
14	a report recommending an increase in salary and allowable expenses for the
15	members of the Council for the Council term beginning in December 2018,

18	WHEREAS, the Anne Arundel County Council, in recognition of the
19	recommendations of the Salary Standard Commission, is hereby adopting the
20	recommendations for a change in salary and allowable expenses within the amounts
21	suggested by the 2017 Salary Standard Commission, therefore,

23	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland,
24	That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

ARTICLE 2. BRANCHES OF COUNTY GOVERNMENT TITLE 2. LEGISLATIVE BRANCH 2-2-101. Compensation. The salaries of the members of the County Council shall be as follows: (1) The Chair of the County Council is entitled to receive, while in that office, an annual salary [of \$40,500 for the entire term] AS FOLLOWS: (I) \$43,350 beginning the first Monday in December, [2002] 2018; (II) \$44,217 BEGINNING THE FIRST MONDAY IN DECEMBER, 2019; (III) \$ 45,101 BEGINNING THE FIRST MONDAY IN DECEMBER, 2020; AND (IV) \$ 46,003 BEGINNING THE FIRST MONDAY IN DECEMBER, 2021. (2) The Vice Chair of the County Council is entitled to receive, while in that office, an annual salary [of \$37,000 for the entire term] AS FOLLOWS: (I) \$ 39,780 beginning the first Monday in December, [2002] 2018: (II) \$ 40,576 BEGINNING THE FIRST MONDAY IN DECEMBER, 2019; (III) \$41,388 BEGINNING THE FIRST MONDAY IN DECEMBER, 2020; AND (IV) \$ 42,216 BEGINNING THE FIRST MONDAY IN DECEMBER, 2021. (3) Each other member of the County Council is entitled to receive, while in that office, an annual salary [of \$36,000 for the entire term] AS FOLLOWS: (I) \$ 38,760 beginning the first Monday in December, [2002] 2018: (II) \$ 39,535 BEGINNING THE FIRST MONDAY IN DECEMBER, 2019; (III) \$ 40,326 BEGINNING THE FIRST MONDAY IN DECEMBER, 2020; AND (IV) \$41,133 BEGINNING THE FIRST MONDAY IN DECEMBER, 2021. 2-2-102. Benefits (a) Retirement plan. Members of the County Council shall participate in the employees' retirement plan in accordance with § 5-3-101 of this Code. (b) Health insurance benefit. Members of the County Council may participate in health programs in the same manner as County employees subject to the following

(1) Any Council member who is a retired County employee as of the beginning of their first elected, first appointed or non-consecutive term in office shall be eligible to participate in the County health insurance program as a retiree and pay the prevailing retiree premium cost.

(2) Any Council member who is not a retired County employee as of the beginning of their first elected, first appointed, or non-consecutive term in office on or after July 1, 2009 shall pay 100% of the premium cost of coverage set by the Personnel Officer for health insurance during their term.

(C) **Transportation Allowance**. SUBJECT TO APPROVAL IN THE BUDGET, A MEMBER OF THE COUNTY COUNCIL SHALL BE ELIGIBLE FOR COMPENSATION FOR TRANSPORTATION EXPENSES, NOT TO EXCEED \$350 PER MONTH, FOR USE OF A PERSONAL VEHICLE TO CONDUCT COUNTY BUSINESS AND PROVIDED THE MEMBER MAKES AN ANNUAL ELECTION BY JANUARY 1 FOR THE UPCOMING FISCAL YEAR.

 (D) **Technology Allowance.** A MEMBER OF THE COUNTY COUNCIL SHALL BE ELIGIBLE FOR A TECHNOLOGY ALLOWANCE, NOT TO EXCEED \$100 PER MONTH, TO COVER THE EXPENSE OF USING A PERSONAL COMPUTER, TABLET, OR CELLULAR PHONE TO CONDUCT COUNCIL BUSINESS.

[(c)] (E) **Other benefits.** Members of the County Council may participate in other benefit programs available to County employees, including health programs, insurance programs, tax-sheltered accounts, deferred compensation programs, credit union services, deductions for charitable purposes, and payroll deductions relating to these programs. Participation in these programs shall be in the same manner as in the participation of County employees. Additional benefit programs authorized for County employees during a councilmanic term of office may not be made available to members of the County Council until the beginning of the next term of office, at which time they shall be fully available unless prohibited in this section. Members of the County Council may not receive County employee paid leave, or payroll deductions other than those associated with the items authorized in this section.

[(d)] (F) **Expenses incurred outside the County.** Subject to approval in the budget, a member may be reimbursed for actual necessary expenses incurred in representing the County beyond the County's geographical boundaries.

[(e)] (G) **Other allowances prohibited.** [A] EXCEPT FOR THE ALLOWANCES PROVIDED FOR IN THIS SECTION, A member is not entitled to any other allowance of any kind.

SECTION 2. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law.
