A BILL ENTITLED

1 AN ORDINANCE concerning: Zoning – Licensed Premises of Licensed Dispensaries of
2 Medical Cannabis

4 FOR the purpose of amending the conditional use and special exception use requirements
5 to clarify where licensed premises of licensed dispensaries of medical cannabis shall
6 be located; and generally relating to zoning.

8 BY repealing and reenacting, with amendments: §§ 18-10-127(a)(1)(as amended by Bill
9 Nos. 75-16 and 83-16); and 18-11-132(1)(as amended by Bill No. 96-16)
10 Anne Arundel County Code (2005, as amended)

12 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
13 *Maryland,* That Section(s) of the Anne Arundel County Code (2005, as amended) (and as
14 amended by Bill Nos. 75-16, 83-16, and 96-16) read as follows:

16 **ARTICLE 18. ZONING**

18 **TITLE 10. REQUIREMENTS FOR CONDITIONAL USES**

20 **18-10-127. Licensed premises of licensed dispensaries, growers and processors of**
21 **medical cannabis.**

1 (a) **Dispensary.** Licensed premises of a licensed dispensary of medical cannabis as a
2 principal use, as defined in COMAR 10.62.01.01, shall comply with all of the following
3 requirements.

5 (1) Premises LOCATED north of [Maryland] U.S. Route 50 [and east] OR PREMISES
6 LOCATED NORTH OF THE NORTHEAST SHORE of the South River may not be located
7 within 1,000 feet of a dwelling or residentially zoned property, or the lot line of a public
8 or private school or real property owned by the Board of Education.

10 **TITLE 11. REQUIREMENTS FOR SPECIAL EXCEPTION USES**

12 **18-11-132. Licensed premises of licensed dispensaries of medical cannabis.**

13
14 Licensed premises of a licensed dispensary of medical cannabis, as defined in
15 COMAR 10.62.01.01, shall comply with all of the following requirements.

17 (1) Premises LOCATED north of [Maryland] U.S. Route 50 [and east] OR PREMISES
18 LOCATED NORTH OF THE NORTHEAST SHORE of the South River may not be located
19 within 1,000 feet of a dwelling or residentially zoned property, the lot line of a public or
20 private school, or the lot line of real property owned by the Board of Education.

22 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect 45 days
23 from the date it becomes law.




