10 That Bill No. 73-09 of the Laws of Anne Arundel County 2009, be and it is hereby repealed.

12 SECTION 2. *And be it further enacted,* That the following rates shall be charged for
13 use of a parking space at the John M. Whitmore Garage, as established by a Commission
14 pursuant to an agreement dated September 27, 1974 between the State of Maryland and
15 Anne Arundel County, Maryland.


