A BILL ENTITLED

1 AN ORDINANCE concerning: Personnel – Position Control in the Classified Service
2 and Exempt Service
3

4 FOR the purpose of obtaining approval to decrease the number of positions in a certain
5 classification in the Classified Service; increase the number of positions in the
6 Exempt Service; and generally relating to position control.
7

8 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
9 *Maryland,* That in accordance with § 6-1-110 of the Anne Arundel County Code (2005,
10 as amended) this Ordinance shall approve a decrease of one Program Specialist II in the
11 Police Department, from the number of positions approved in this classification as part of
12 the annual budget and appropriation ordinance.

14 SECTION 2. *And be it further enacted,* That in accordance with § 6-2-103(a) of the
15 Anne Arundel County Code (2005, as amended) this Ordinance shall approve an increase
16 of one Executive Management Assistant II in the exempt service in the Office of the
17 County Executive, in addition to the number of positions approved in this classification
18 as part of the annual budget and appropriation ordinance.

20 SECTION 3. *And be it further enacted,* That the provisions of this Ordinance shall
21 take effect 45 days from the date it becomes law.




