## A BILL ENTITLED

1	AN ORDINANCE concerning: Snug Harbor Waterways Improvement District
2	Approval of Loan and Assignment Agreement
3	
4	FOR the purpose of obligating the County to levy the special tax known as the
5	waterways improvement district assessment on the Snug Harbor Waterways
6	Improvement District in an amount sufficient to repay a loan from Sandy Spring
7	Bank to the Snug Harbor Waterways Improvement District in each of five (5)
8	fiscal years during the term of the loan.

10	WHEREAS, the Snug Harbor Waterways Improvement District has been duly
11	formed and created, pursuant to procedures set forth in Anne Arundel County
12	Code, Article 4, Title 7; and
13	
14	WHEREAS, pursuant to § 4-7-406(k) of the Anne Arundel County Code, the
15	purposes of the Snug Harbor Waterways Improvement District include "providing
16	for the repair of the bulkhead, pilings, and catwalk; the dredging of the harbor and
17	the channel; and future maintenance and other improvements as permitted by § 4-
18	7-405(b), should future maintenance or improvements become necessary"; and

20	WHEREAS, the Snug Harbor Waterways Improvement District, Inc. (the
21	"District") is the civic or community association that meets the requirements of §
22	4-7-101(d) that administers the District; and

24	WHEREAS, the District is entering into a loan agreement with Sandy Spring
25	Bank in the amount of \$112,200, with a term of five (5) years, to be used for
26	maintenance of a dredging project (the "Loan"); and

WHEREAS, to enable the District to obtain the Loan from Sandy Spring Bank by providing a source of funds for repayment of the Loan, the County is undertaking the obligation set forth in this Ordinance; now, therefore,

SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That the County shall be obligated to levy the special tax known as the Waterways Improvement District assessment on the Snug Harbor Waterways Improvement District in an amount sufficient to repay the Loan from Sandy Spring Bank to Snug Harbor Waterways Improvement District, Inc., in each of up to five (5) fiscal years during the term of the Loan, beginning in the County's Fiscal Year 2018.

SECTION 2. And be it further enacted, That the County undertakes no obligation with regard to the Loan except as expressly described in this Ordinance, is neither a co-obligor nor guarantor of the Loan, and does not commit the full faith and credit of the County to repayment of the Loan.

SECTION 3. And be it further enacted, That the County Executive is hereby authorized to enter into such other and further agreements with the Association and Sandy Spring Bank as are necessary to disburse directly to Sandy Spring Bank such amounts of the Waterways Improvement District assessment levied on the Snug Harbor Waterways Improvement District as are collected by the County and are necessary to repay the Loan consistent with this Ordinance.

SECTION 4. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law.
