A BILL ENTITLED

1 AN ORDINANCE concerning: Personnel – Classified Service in the Legislative Branch –
2 Position Control

4 FOR the purpose of increasing and decreasing certain positions approved in certain
5 classifications as part of the Annual Budget and Appropriation Ordinance in the Office of
6 the County Auditor, Legislative Branch; providing for the applicability of this Ordinance;
7 and generally relating to the classified service.

9 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
10 That in accordance with § 6-1-110 of the Anne Arundel County Code (2005, as amended)
11 this Ordinance shall approve an increase of one Legislative Management Assistant I (NR 15)
12 position in the Office of the County Auditor, Legislative Branch, to the number of positions
13 approved in this classification as part of the Annual Budget and Appropriations Ordinance.



15 SECTION 2. *And be it further enacted,* That in accordance with § 6-1-110 of the Anne
16 Arundel County Code (2005, as amended) this Ordinance shall approve a decrease of one
17 Legislative Administrative Secretary (NR12) position in the Office of the County Auditor,
18 Legislative Branch, from the number of positions approved in this classification as part of the
19 Annual Budget and Appropriation Ordinance.

21 SECTION 3. *And be it further enacted,* That changes to position control under Sections 1
22 and 2 of this Ordinance shall take effect at the beginning of the first full pay period on or
23 after the effective date of this Ordinance.




