A BILL ENTITLED

1 AN EMERGENCY ORDINANCE concerning: Capital Budget and Program and Capital
2 Projects Bond Ordinance – New Police C.I.D. Facility – Amending Scope and
3 Description of Project
4

5 FOR the purpose of amending the Capital Budget by amending the scope and description
6 of the New Police C.I.D. Facility capital project; amending the Capital Program and
7 Capital Projects Bond Ordinance; making this Ordinance an emergency measure; and
8 generally relating to the New Police C.I.D. Facility capital project.

10 BY amending: Capital Budget
11 Capital Program
12 Capital Projects Bond Ordinance

14 WHEREAS, Section 716 of the Charter authorizes the County Council, upon
15 request of the County Executive and by the affirmative vote of five members of
16 the County Council, to amend the capital budget; and
17

18 WHEREAS, the County Executive is requesting that the scope and description of
19 the New Police C.I.D. Facility capital project, Capital Project No. F572800 be
20 amended to identify a proposed alternative location for the new facility and to
21 remove reference to providing space for the Crime Lab and Evidence Collection;

24 WHEREAS, the amendment to the scope and description of the New Police
25 C.I.D. Facility capital project does not expand the capital project; and

1 WHEREAS, in accordance with Section 716 of the Charter, the Planning
2 Advisory Board has recommended this amendment to the Capital Budget; now,
3 therefore,
4

5 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
6 *Maryland,* That the Capital Budget for the fiscal year ending June 30, 2018, is hereby
7 amended by revising the scope and description of the New Police C.I.D. Facility capital
8 project, Capital Project No. F572800, to state: "This project provides for the acquisition
9 and renovation / reconfiguration of property known as The Severn Commons Office
10 Building located at 8666 Veterans Highway in Millersville for the purpose of housing the
11 Criminal Investigation Division (CID)."
12

13 SECTION 2. *And be it further enacted,* That the Capital Program and the Capital
14 Projects Bond Ordinance for the fiscal year ending June 30, 2018, are hereby amended in
15 accordance with the provisions of this Ordinance.
16

17 SECTION 3. *And be it further enacted,* That this Ordinance is hereby declared to be
18 an emergency ordinance and necessary for the immediate preservation of the public
19 peace, health, safety, welfare, and property, and being passed by the affirmative vote of
20 five members of the County Council, the same shall take effect from the date it becomes
21 law.




