A BILL ENTITLED

1 AN ORDINANCE concerning: Current Expense Budget – Supplementary Appropriations
2 – Shoreham Beach Special Community Benefit District
3

4 FOR the purpose of making supplementary appropriations from unanticipated revenues to
5 the Shoreham Beach Special Community Benefit District for the fiscal year ending
6 June 30, 2018.
7

8 BY amending: Current Expense Budget
9

10 WHEREAS a revised budget request has been submitted on behalf of the
11 Shoreham Beach Special Community Benefit District (“SCBD”) to appropriate
12 revenues that were not appropriated for the fiscal year ending June 30, 2018; and
13

14 WHEREAS, these revenues were not anticipated in the Current Expense Budget;
15 and
16

17 WHEREAS, Section 712 of the Charter authorizes the County Council, upon the
18 recommendation of the County Executive, to make supplementary appropriations
19 from revenues received from sources not anticipated in the budget or from
20 revenues received from anticipated sources but in excess of budget estimates for
21 the current fiscal year, provided that the Controller shall first certify in writing
22 that the funds are available for appropriation; and


24 WHEREAS, the County Executive has recommended supplementary
25 appropriations, and the Controller has certified in writing that such funds are
26 available for appropriation; now, therefore,

1 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
2 *Maryland,* That the Current Expense Budget for the fiscal year ending June 30, 2018, is
3 hereby amended by making supplementary appropriations from revenues received from
4 sources not anticipated in the budget to the Shoreham Beach SCBD in the amount of
5 \$43,000.

7 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect from the
8 date it becomes law.




