A BILL ENTITLED

AN ORDINANCE concerning: Sherwood Forest Special Community Benefit District -1 2 Approval of Loan and Assignment Agreement 3 FOR the purpose of obligating the County to levy the special tax known as the special 4 community benefit assessment on the Sherwood Forest Special Community Benefit 5 District in an amount sufficient to repay a loan from First Citizens Bank & Trust 6 Company to The Sherwood Forest Club, Inc., in each of ten (10) fiscal years during 7 the term of the loan. 8 9 WHEREAS, the Sherwood Forest Special Community Benefit District has been 10 duly formed and created, pursuant to procedures set forth in Anne Arundel 11 County Code, Article 4, Title 7; and 12 13 WHEREAS, pursuant to § 4-7-204(hhh)(2) of the Anne Arundel County Code, 14 the Sherwood Forest Special Community Benefit District "is established for the 15 purpose of providing total administration, personnel, operation, maintenance, and 16 repair or replacement of all community facilities and property, including 17 recreational areas and all community buildings, but excluding roads and garbage 18 collection; providing security, erosion control, and snow removal; purchasing, 19 leasing, developing, or constructing real property; purchasing or leasing, 20 operating, and maintaining vehicles, tools, and other equipment used in carrying 21 out the purposes of the district; and payment of all legal, administrative, and 22 organizational expenses of the district"; and 23 25

WHEREAS, The Sherwood Forest Club, Inc. (the "Club") is the civic or

community association that meets the requirements of § 4-7-101(d) that administers the District; and

WHEREAS, the Club is entering into a loan agreement with First Citizens Bank & Trust Company in the amount of \$475,000, with a term of ten (10) years, to be used to provide funding for repair and maintenance of community property, including the main pier, community pool, community tennis courts, and clubhouse (the "Loan"); and

WHEREAS, to enable the Club to obtain the Loan from First Citizens Bank & Trust Company by providing a source of funds for repayment of the Loan, the County is undertaking the obligation set forth in this Ordinance; now, therefore,

SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That the County shall be obligated to levy the special tax known as the special community benefit assessment on the Sherwood Forest Special Community Benefit District in an amount sufficient to repay the Loan from First Citizens Bank to The Sherwood Forest Club, Inc., in each of up to ten (10) fiscal years during the term of the Loan, beginning in the County's Fiscal Year 2018 Fiscal Year 2019.

SECTION 2. And be it further enacted, That the County undertakes no obligation with regard to the Loan except as expressly described in this Ordinance, is neither a co-obligor nor guarantor of the Loan, and does not commit the full faith and credit of the County to repayment of the Loan.

SECTION 3. And be it further enacted, That the County Executive is hereby authorized to enter into such other and further agreements with the Club and First Citizens Bank & Trust Company as are necessary to disburse directly to First Citizens Bank & Trust Company such amounts of the special community benefit assessment levied on the Sherwood Forest Special Community Benefit District as are collected by the County and are necessary to repay the Loan consistent with this Ordinance.

SECTION 4. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law.
