18	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland,

ARTICLE 4. FINANCE, TAXATION, AND BUDGET

TITLE 7. SPECIAL COMMUNITY BENEFIT DISTRICTS, SHORE EROSION CONTROL DISTRICTS, AND WATERWAYS IMPROVEMENT DISTRICTS

4-7-204. Districts established.

(TT) Mil-Bur Special Community Benefit District.

(1) THE LIMITS OF THE MIL-BUR SPECIAL COMMUNITY BENEFIT DISTRICT ARE SET FORTH ON THE PLATS OF MIL-BUR, MIL-BUR ADDITION, AND THE W.L. COOK SUBDIVISIONS AS RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY IN PLAT BOOK 32, PAGE 88-90; PLAT BOOK 125, PAGE 20; AND PLAT BOOK 225, PAGE 50.

(2) THE DISTRICT IS ESTABLISHED FOR THE PURPOSE OF ACQUIRING, MAINTAINING, AND IMPROVING ALL COMMUNITY REAL AND PERSONAL PROPERTY, AND DEFRAYING THE ADMINISTRATIVE COSTS NECESSARY TO ACCOMPLISH THIS PURPOSE, INCLUDING THE REPAYMENT OF ANY LOAN, INTEREST THEREON, AND ANY NECESSARY INSURANCE COSTS.

(3) THE MIL-BUR CLUB, INC., A CIVIC OR COMMUNITY ASSOCIATION THAT MEETS THE REQUIREMENTS OF § 4-7-101(D), SHALL BE RESPONSIBLE FOR ADMINISTERING THE SPECIAL COMMUNITY BENEFIT DISTRICT ASSESSMENTS IN FURTHERANCE OF THE PURPOSES OF THE MIL-BUR SPECIAL COMMUNITY BENEFIT DISTRICT.

4-7-205. Rate of tax.

(c) Uniform assessment for each improved lot. The special community benefit tax shall be a uniform assessment per improved lot in the MIL-BUR SPECIAL COMMUNITY BENEFIT DISTRICT AND THE Sherwood Forest Special Community Benefit District.

SECTION 3. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law.
