### A BILL ENTITLED

1 AN ORDINANCE concerning: Approval of Lease Agreement for Andover Equestrian  
2 Center

3  
4 FOR the purpose of approving an agreement to lease County-owned property known as the  
5 Andover Equestrian Center, located at 433 Andover Road, Linthicum, Maryland  
6 21090, to Morningside Stables, LLC.

7  
8 WHEREAS, the County owns real property identified as 433 Andover Road,  
9 Linthicum, Maryland 21090, known as the Andover Equestrian Center (the “Leased  
10 Property”); and

11  
12 WHEREAS, the County desires to lease the Leased Property to Morningside  
13 Stables, LLC for a term of 30 years, as set forth in a Lease Agreement, incorporated  
14 herein by reference as if fully set forth; and

16 WHEREAS, § 8-3-301 of the County Code requires that certain leases of County-  
17 owned property that specify a term, including renewal options, of three years or  
18 more, be approved by ordinance of the County Council; now, therefore,



20 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
21 That the Lease Agreement, incorporated herein by reference as if fully set forth, which  
22 leases the Leased Property to Morningside Stables, LLC, is hereby approved.

24 SECTION 2. *And be it further enacted,* That the Lease Agreement is incorporated  
25 herein by reference as if fully set forth. A certified copy of the Lease Agreement shall be  
26 permanently kept on file with the Administrative Officer to the County Council and the  
27 Office of Central Services.

1 SECTION 3. *And be it further enacted*, That this Ordinance shall take effect 45 days  
2 from the date it becomes law.


