A BILL ENTITLED

AN ORDINANCE concerning: Property Tax and Semiannual Payment Service Charge 1 2 3 FOR the purpose of levying and imposing a property tax for the use of Anne Arundel County for the taxable year beginning July 1, 2019, and ending June 30, 2020; fixing 4 5 the rate of the County property tax for the taxable year; and establishing the service charge to be paid by a property owner electing to pay real property taxes and all other 6 taxes and charges billed on the real property tax bill under a semiannual payment 7 schedule. 8 9 SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, 10 11 That a County property tax for the taxable year beginning July 1, 2019, and ending June 30, 2020, is hereby levied and imposed on all assessments, persons, or property subject to 12 ordinary taxation in Anne Arundel County, and that the rate of taxation for such taxable 13 14 year is hereby fixed at: 15 (1) \$0.935 on each \$100 of the full assessed value of such real property, and \$2.337 16 17 on each \$100 of the full assessed value of such personal property, exclusive of said property located within the corporate limits of the City of Annapolis and the Town of Highland 18 Beach: 19 20 (2) \$0.561 on each \$100 of the full assessed value of such real property, and \$1.402 21 on each \$100 of the full assessed value of such personal property, located within the 22 corporate limits of the City of Annapolis; and 23

(3) \$0.905 on each \$100 of full assessed value of such real property, and \$2.262 on each \$100 of the full assessed value of such personal property, located within the corporate limits of the Town of Highland Beach.

SECTION 2. And be it further enacted, That each property owner electing to pay real property taxes and all other taxes and charges billed on the real property tax bill under a semiannual payment schedule, for the taxable year beginning July 1, 2019, and ending June 30, 2020, shall pay a service charge of 0.57% 0.58% of the amount of the tax due at the second installment.
